
Customers and Distributors of Gillows' Eighteenth-Century Windsor Chairs

The aim of this study is to analyse the scale of production and geographical distribution of Gillows' Windsor chairs to both domestic and overseas customers during the eighteenth century. Source information is recorded in the Lancaster *Day Books* (1756–1768), the *Journal* (1769–1774) and the Lancaster *Waste Books* (1771–1797, see Appendix I). These all record a two-way flow of transactions revealing not only the prices charged to customers and merchants for different types of furniture but also the cost of purchasing materials and products. In the case of the *Waste Books*, materials and products include Windsor chair bottoms, parcels of nails, imported mahoganies, zebra wood, 'bundles of good mats' for packing furniture, bags of cotton, casks of rum, casks of sugar and casks of coffee. Together, these records indicate that orders for Windsor chairs between 1756 and 1797 far exceeded those for upholstered chairs, and if the size of many of the orders for Windsor chairs dispatched to merchants is taken into account the scale of production relative to other chairs appears to be even more significant (Figure 1).

SUBCONTRACTORS


Gillows' supply of Windsor chairs between 1769 and 1791 was heavily dependent upon their manufacture by subcontractors.² The *Petty Ledgers* not only indicate the involvement of external manufacturers in the making of Windsor chairs but also, albeit to a much lesser extent, in the supply of walnut and mahogany upholstered chairs, which were often made in parallel with Gillows' own journeymen. Previous studies of Gillows' Windsor chairs by Susan Stuart have identified the involvement of subcontractors such as William Harrison of Preston, John Rumley and James Beck of Ulverston, and James Wilcox senior and junior of Lower Bentham prior to the involvement of Gillow's own workmen such as John Harrison and Thomas Toulmin in the 1790s.³ Some contractors, such as James Beck and John Rumley supplied whole chairs or parts of chairs, such as chair bottoms (seats), while William Harrison of Preston had supplied both walnut chairs of an unspecified design in 1756 and unpainted Windsor chairs in 1760.

The *Petty Ledgers* reveal not only the wages paid by Gillows to their own journeymen on a piece-rate system but the lump sums paid to subcontractors such as James Wilcox senior and junior for making Windsor chairs as well as a reimbursement for independently sourced materials, components and any associated cartage or carriage of these materials.⁴ With respect to Windsor chairs such items comprised timbers such as ash, plain ('plane' or sycamore) bottoms, nails, plates and oil. Subcontractors would normally endorse the left-hand side of the Petty ledger with their signature on receipt of a lump sum payment according to details agreed on the right-hand side. The Wilcox workshop was probably located in the barn next to the Punch Bowl Inn at Lower Bentham, Yorkshire, some fourteen miles north-east of Lancaster, where the Wilcox family had lived for generations.⁵ Travelling by wagon to Lancaster would probably have taken four to five hours.

Significant fluctuations in the sales of Gillows' Windsor chairs, based on surviving *Waste Book* records (Figure 2), suggest the important role of external makers in meeting periodic demand during the 1780s prior to the involvement of John Harrison in the following decade. At that time the *Petty Ledgers* indicate that Harrison was being paid a weekly wage in a similar fashion to Gillows' thirty-two journeymen listed in the 'Regulation of Journaymens [sic] Wages under Richard & Robert Gillow' of 1785.6 By 1798 and 1799, when the *Estimate Sketch Book* illustrations of Gillows' bow-back Windsor chairs first appeared, with annotations to each drawing stating for the 'making by John Harrison', his involvement in making Windsor chairs had almost ceased.7 By 1804 the *Petty Ledgers* indicate that he was primarily involved in rushing and caning light chairs, which in a sense was a sequel to his much earlier involvement in making rush-seated chairs of many patterns.8 However, it is not always clear

2 Annual sales of Gillows' Windsor chairs, 1770–1797


whether individual workmen were employed or sub-contracted, because Gillows' *Letter Books* include letters signed by Richard and Robert Gillow which use the term journeyman and workman synonymously, enquiring for example about the availability of suitable upholsterers from other workshops.⁹

WINDSOR CHAIR TYPES

One of the earliest references to bow-back Windsor chairs is to be found in a *Petty Ledger* entry dated 19 February 1773, when James Wilcox senior 'demanded' payment from Gillows for 'stuff for legs and bows' and on 17 August 1774 another payment to cover the cost of 'ash wood for bows'. Subsequent descriptions follow some twenty-five years later in the 1798 and 1799 *Estimate Sketch Books*. Annotations to the three illustrations of bow-back Windsor chairs specify that they were to be made out of mahogany and cherry tree, elm and cherry tree and mahogany by John Harrison; prior to this in May 1792 he had made eighteen cherry tree and mahogany Windsor chairs which were probably the same eighteen Windsor chairs dispatched by Gillows to Thomas Barrow on 5 November 1793. This was probably not an exceptional situation since Jos. Wilcox had supplied high-back Windsor chairs to Gillows in July 1802, at two guineas a dozen, predating the *Estimate Sketch Book* design of 1806 (Figure 3). This illustration was probably intended to clarify design details for Wilcox, who was already involved as a subcontractor and being paid on a lump sum basis. To Annotations to the 1806 drawing describe it as a 'High Back Ash Windsor Chair' to be made by

Jos. Wilcox. It cost 3s 6d, materials such as wood for bows and feet 1s 6d, the bottom 1s 2d, deal for spindles $4\frac{1}{2}d$ and glue, nails & plates at 3d, total 6s $9\frac{1}{2}d$. A footnote also states that the chair was to be painted green.

Figure 4 illustrates a green painted Windsor chair with many similarities to the sketch book drawing but with lower or cut-down legs. In this example the curved lower stretcher, described as a 'stricher rail' in the 1799 Estimate Sketch Books, has a flattened edge to the outer curve probably to lend strength to the dowel and socket joints which were omitted in later versions (Figure 5). This chair has an elm seat, ash bow, legs that are mortised through the seat and spindles that still retain vestiges of a blue-grey or 'lead colour' undercoat followed by green paint. Another feature worth noting for future comparison is the parallel scoring on the ash bow, probably made to facilitate drilling to house the spindles, and which could be disguised by paint (Figure 6). Thus even if the chair was subsequently stripped of original finish the marks may be useful indicators that a painted finish had been applied.

Although no sketches of the low-back Windsor chair survive, the *Waste Books* make a clear distinction between low-back and high-back chairs from June 1771 onwards, when eighteen green painted low backs were dispatched to Messrs. Abram & John

Rawlinson for their customers in the West Indies. Furthermore, on 25 January 1783 the Petty Ledger refers to '24 Windsor chairs low backs and yoaks' being supplied by James Wilcox at a unit price of 3s 6d to cover 'making' costs. A 'yoak' would probably have been the capping or cresting rail harnessing together the three parts forming the arms on a low back Windsor chair. An example of a low-back Windsor chair with such a compound arm structure, bent underarm supports and a lower curved 'stricher rail' arrangement similar to those used on Gillows' high-back Windsors has been recorded by Susan Stuart and probably represents the low-back version. 12

PAINT FINISHES

Painted Windsor chairs listed in Gillows' dispatch records (Day Book, Journal and Waste Books) accounted for 198 (70%) of the 289 orders for Windsor chairs dispatched to both domestic and overseas customers. Total production amounted to 3880 chairs. The importance of green-painted Windsor chairs is highlighted by the scale of exports, mainly to the West Indies, during the eighteenth century. Out of the 3008 Windsors exported, 2792 (93%) were painted (mainly green) or supplied with paint in jars or bladders for application on arrival, probably to minimise damage in transit (Appendix I).

Where painted chairs were concerned, a number of references were made in the Waste Books as to whether one or more coats of paint had been applied or were necessary prior to delivery to a customer. For example, an entry dated 14 January 1771 notes that twelve Windsor chairs painted three times were sent to John Machell of Penny Bridge Hall, Westmorland, and on 29 November 1780 twelve Windsor chairs were sent loose to St Elizabeth, Jamaica with '2 bladders in a little box containing 2 sorts of paint for ditto lead colour for the first time over and verdegrass [verdigris] green to finish mixed up in the best manner @ 8/-'.13

The requirement for plates and oil suggests that the verdigris paint was being made in Wilcox's workshop. According to Robert Dossie's 1758 book The Handmaid To The Arts, the process used to make verdigris green involved copper plates being coated with vinegar (ascetic acid) prior to being dried and scraped into an oil such as linseed. 14 A similar method of preparation was described by P. F. Tingry in 1816. 15

A different context in which plates were occasionally referred to was related to the mending of chairs. For example, the Gillows Journal, dated September 1773, refers to 'mending a chair with 2 iron plates, screws and labor' at a cost of 1s for Jas. Fenton. 16

Other paint colours were also used; in June and July 1786 there were two orders for Windsor chairs painted and 'stroked' blue followed by varnishing, and in December 1790 one low back Windsor chair was japanned a buff brown colour prior to dispatch.

DOMESTIC CUSTOMERS

Of the 289 Windsor chair orders 155 were for domestic customers, of which 15, totalling 155 chairs, were trade customers such as upholsterers, chairmakers and Gillows' own premises in London. The geographical distribution of Windsor chairs appears to be largely the same as those for other types, and focuses primarily on the counties of Lancashire, Cheshire, Westmorland and Cumberland (Maps 1–5). It may be significant that only four orders for Windsors were sent to Gillows' premises in London (1781, 1788, 1790 and 1792), comprising a total of ninety chairs and '2 children's chair stools'. This could indicate a dominant role for the Thames Valley and London makers in supplying Windsor chairs to Gillows' London customers. Furthermore, it raises the possibility that workshops in the Thames Valley and London may have supplied Windsor chairs to Gillows' specification to their Oxford Street shop.

The *Waste Books* occasionally refer to the transportation of furniture by sea, canal, turnpike and 'Great Roads'. Shipment by sea was used to deliver Windsor chairs to Gillows premises in Oxford Street, London by the ships *Liberty*, *Myrtle* and *Laurel*.¹⁷ In July 1781 four Windsor chairs went by the *Peggy* to Liverpool and then by the Trent and Mersey canal to Cavendish Bridge and thence by road to John Pares' property in Leicester, probably Hopwell Hall.¹⁸ By comparison most of the fan-back chairs destined for customers and merchants in northwest England (Map 2) went by the evolving canal and turnpike network.¹⁹ For example, in Lancashire a recently constructed section of the Leeds and Liverpool canal facilitated the delivery in February 1786 of twelve upholstered fan back chairs from Liverpool to Thomas Eccleston at Scarisbrick Hall near Ormskirk. The ongoing nature of this infrastructure improvement is highlighted in William Tunnicliff's *New Map of Lancashire* in 1787, in which a future section of this canal towards Blackburn was labelled as 'intended'.²⁰

DOMESTIC USES

The increasing prosperity of sections of the population in northwest England during the early stages of the industrial revolution was reflected in the spectacular scale of building activity, emphasised by Nikolaus Pevsner in his publication on North Lancashire.²¹ This was no doubt reflected in the demand for fashionable furniture intended for particular rooms in conjunction with interior decoration of new and enlarged domestic properties, and Gillows were fully able to respond to this demand.²² They supplied a range of new furniture and furnishings to various substantial and newly-built properties around or within Windermere such as Belle Isle, completed in 1781 for the Christian Curwen family.²³ In May 1788 twelve Windsor chairs painted green were delivered to this house, followed in October the same year by delivery to








Map I Windsor chairs, 1760-1797




Map 2 Fan back chairs, 1756-1794

their property at Workington Hall of '36 very neat and light japanned chairs, ornamented in different colours and varnished matted (rush) bottoms'.²⁴

Brathay Hall, built in the late eighteenth century at the northern end of Windermere for George Law, a West Indies trader, was supplied by Gillows with twelve mahogany escutcheon-back chairs in 1784 and six satinwood Chinese pattern chairs in 1785. ²⁵ In December 1788 he was sent 'A Windsor sofa made to fit a curve painted once over £1–3–6' and '4 Windsor chairs painted once over @ 7/9'. A similar arrangement was used in the United States of America when in 1803 Commodore John Barry had 'a green Windsor Sopha and 6 chairs'. ²⁶ The English tradition of making painted Windsor sofas similar to Thames Valley Windsor chairs is suggested by a surviving example with vestiges of original red groundwork under the seat from Claremont House, Surrey (Figure 7). ²⁷ A number of accompanying comb back Windsor chairs (Figure 8), without arms, with dark green paint over the same red ground work suggests that all of these Windsor chairs were intended for use as 'forrest' chairs in an outdoor setting. ²⁸

Another property, Calgarth Park on the east side of Windermere, was completed in 1789 for Dr Watson, the 'absentee' Bishop of Llandaff, who purchased from Gillows two Windsor chairs, twelve black-stained cottage chairs and twelve kitchen chairs in 1789, followed by twelve rout chairs in 1792.²⁹

According to the Waste Books the clientele for Windsor chairs were essentially the same as those supplied with upholstered walnut and mahogany chairs as well as with stained and japanned rush and cane-seated light chairs which were the subject of a previous study (Appendix III).3° These customers included West Indies and British



merchants, manufacturers, clergy, teachers, attorneys-at-law, county high sheriffs and landowners. In a small number of cases the documentation refers to the rooms in which the chairs were intended to be used. For example, six Windsor chairs were supplied to Mr Lawson at Manchester Free Grammar School in August 1775, four green-painted Windsor chairs for the best bedroom at Captain Russell's property (April 1780), six green-painted Windsor chairs for Edmunsham's factory at Catshaw (April 1787), three Windsor chairs with high seats and low backs for Maude's Bank at Kendal (December 1787), two green-painted Windsor chairs together with two white and green dressing tables to Hornby Hall (July 1792), twelve green-painted Windsor chairs for the hall at Whittington Hall (Oct 1792) and six green-painted versions for the dressing room together with two painted children's Windsor chairs for the front bedroom at Jonathan Peel's house near Accrington (May 1794). A *Petty Ledger* entry dated 10 December 1781 also refers to James Wilcox supplying Gillows with a mahogany Windsor chair as a 'dressing chair' at a price of 5s, incorporating an 'old sort of Yoak and long arms'.

OVERSEAS CUSTOMERS

From 1764 onwards the dispatch records list 134 orders (46% of the total) relating to the export of 3008 Windsor chairs of which 2792 (93%) were painted (mainly green, Figure 9). Only 26 entries comprising 564 Windsor chairs clearly specify their West Indies destination, mainly Jamaica. However, despite the limited details relating to shipments and the involvement of Lancaster and West Indies merchants, ship's masters, captains and ship owners, there are a number of other indicators of destination which are summarised in the introduction to Appendix I. For instance, the involvement of a Gillows family trading partnership (Carter, Worswick, Gillow & Co.) is recorded in the Waste Books between 1783 and 1791. By comparison with Windsor chairs the exports of different types of upholstered mahogany chairs such as the Fan Backs, Gothic backs, Splat Backs and Upright Splat Backs never exceeded 27% of all orders.

While the *Waste Books* tell us about the volume of annual overseas sales the identity of the ultimate customer is seldom recorded because of the involvement of third parties, usually merchants, in the sales process. However, there are a few exceptions where an individual owner is specified. For instance, on 29 November 1780 twelve Windsor chairs were sent, with legs loose and 'bladders in a little box containing 2 sorts of paint' to a Doctor White of St Elizabeth, Jamaica; six Windsor chairs were dispatched to 'The Honourable Wm. Payne Georges, Chief Justice of St. Kitts' on 29 March 1784, with two jars of paint; and on 30 September 1791 a Mrs Delegal of Barbados was sent six Windsor chairs.

In view of the scale of purchases of Windsor chairs by Lancashire merchants such as William Bishop & Co., it is probable that they were primarily intended for export rather than to be sold within their immediate region in an attempt to compete with Gillows, their supplier. For example, on 2 December 1779 sixteen Windsor chairs were dispatched to Mr Jas. Brooks, merchant, of High Street, Liverpool and twelve Windsor chairs were sent to Messrs. Edmund Chamley & Co. of Liverpool on 30 April 1795, possibly for eventual shipment to their trading partners Thomas Higham & Co. in the West Indies. A subsequent order for twenty-four lozenge-back mahogany chairs was dispatched by Messrs. Edmund Chamley & Co. on 14 April 1797 on the *Nancy*, probably for export.

Gillows were certainly not the only English firm to supply Windsor chairs to the West Indies. For example, in February 1770 the tobacco merchants John Norton and Sons of London and Virginia supplied a dozen Windsor chairs, together with a multiplicity of other products to Mann Page, a lawyer and planter in Virginia, as part of a trade involving frequent shipments of tobacco to England between 1750 and 1795.31 Recent research by Nancy Goyne Evans has revealed the involvement of a London factor, John Parkinson, who in 1772 exported two consignments totalling '42 high backed Green Windsor Chairs', probably emanating from a Thames Valley workshop, to the care of Martin Williams Esq., a plantation owner of the Old Hope estate in Westmoreland, Jamaica.³² In this respect it is noteworthy that the trade label of William Webb, c. 1780, at Newington turnpike, on the Surrey side of the Thames, includes a footnote stating 'N.B. for Exportation'.33 Both Gillows and the London/Thames Valley makers competed directly with North American chair manufacturers for West Indian business. Prior to the American War of Independence the largest consignments of chairs exported from North America to the West Indies were from Philadelphia and New Hampshire.34 The growth in sales between 1782 and 1785 (see Figure 1), following the conclusion of the American War of Independence in 1783, may to a large extent be the result of restrictions imposed by the British on exports from the United States to the West Indies, which allowed Gillows to capture customers previously supplied from North America.³⁵

CONCLUSIONS

The involvement of Lancaster, Liverpool and West Indies merchants, many with Lancashire origins, in the sales and marketing of Gillows Windsor chairs and other types of furniture may have contributed to the success and longevity of the firm during the 18th century. In this respect it should be noted that the biggest demand was from overseas customers who accounted for 3008 (78%) of 3880 chairs produced, leaving only 872 (22%) made for the domestic market.

The similar customer profiles and distribution maps of both Windsor chairs, upholstered chairs and a diverse range of rush and cane seated chairs suggest a strong regional character to Gillows' business and confirms previous studies.³⁶ Furthermore it is evident that Gillows' distribution pattern was moulded by an awareness of the competition from both London/Thames Valley and North American workshops.
